



	M/S M S. Traders	Quoted specification is not as per tender specs (quoted height of chair is 780mm (30.70 inch) while required height was 36 inch).
	M/S Khan Traders	Due to non active status of GST and non provision of technical proposal on firm's letter head pad which is violation of clause No. 28 of bidding documents.
